Program Statement—80%

- Rationale for Project & Future Implications (20%) Need for the project in the current field of study, significance of
 the project for current and future studies. How the project can contribute to faculty research, as well as to the field
 at large.
- O Review of Literature / Relevant Background (15%) For research projects, complete, relevant, and accurate literature review; for creative projects, discussion of the relevant history or tradition.
- Objectives (15%) —Objectives of the project; expected outcomes.
- Methodology (Processes, Measures, Analysis) (20%) Processes applicants will use to achieve objectives including
 the creative process and/or how data will be collected, used, and analyzed.
- Timeline (5%) Anticipated timeline for the proposed project. Should detail how the work will be completed over the grant period.
- External Funding (if applicable)—How research completed through this grant will create opportunities for future external funding.
- O References and bibliography (5%) —A list of all relevant references cited in the application and, if it is useful, a complete bibliography. This section is not part of the Program Statement and is not included in the five-page limit.
- Progress since last grant (if applicable)—Describe progress on previous internal funding.
- **Budget and Budget Justification—20%**—Itemized budget; justification of expenses.

Additional considerations may include—1) first time applicant, 2) direct costs such as funds needed for equipment, travel, and supplies, 3) pre-tenure/promotion, and 4) history of meeting objectives if previously funded.
